The Board of Directors is legally and ethically responsible for all activities of the RMN. To that end it:

- Determines how the organization will carry out its mission through long- and short-range planning
- Adopts an annual budget and provides fiscal oversight
- Recruits, orients, and develops board members
- Hires and evaluates the performance of the Executive Director
- Evaluates the overall performance of the organization in achieving the mission
- Establishes policies for the effective management of the organization
- Selects officers from among its members and selects others in the movement to serve on committees as needed to carry out its work
